Payment: Consignee shall remit payment to the Consignor for the sold Item, as stated below, less any applicable commission and fees, such as credit card processing fees, and freight packaging.

We release funds of over \$50.00 each month on the 20th, and checks will be ready for pick up on the 21st or after that unless it is at the end of a contract period. We prefer to write larger checks vs. smaller ones, especially if you have several items on consignment with us.

Promotion: Consignee shall undertake reasonable efforts to promote the sale of the Items through its marketing channels, including but not limited to online platforms, social media, and physical displays.

Maintenance and Insurance: Consignee agrees to exercise reasonable care in the handling, storing, and displaying the Items. Consignor acknowledges that Consignee shall not be responsible for any loss, damage, or theft of the Items while in its possession. Consignor is responsible for insuring the Items against loss or damage during the consignment period.

Termination: Either party may terminate this Agreement upon [Termination Notice Period] days' written notice to the other party. Upon termination, Consignee shall return any unsold Items to the Consignor within [Return Period] days of the termination date.

Governing Law: This Agreement shall be governed by and construed in accordance with the laws of the State of Ohio.

Entire Agreement: This Agreement constitutes the entire understanding between the parties with respect to the subject matter herein and supersedes all prior agreements, understandings, negotiations, and discussions, whether oral or written.
